6. Proposed timing or schedule (including phasing, if applicable):

Consistent with the approval process outlined in Appendix A of the current Kitsap Countywide Planning Policies (CPPs), proposed adoption following proper notice and public hearing by the Kitsap County Board of Commissioners is anticipated in September 2021. Following Kitsap County action and per Appendix A, the adopting ordinance will be transferred to the Cities of Bainbridge Island, Poulsbo, Bremerton and Port Orchard for ratification. At minimum, three Kitsap cities must ratify for the County adopting ordinance to take effect.

7. Do you have any plans for future additions, expansion, or further activity related to or connected with this proposal? If yes, explain.

Following the proposed policy revisions and not subject to this SEPA review, the Kitsap Regional Coordinating Council (KRCC) is expected to embark on phase 2 of a CPP update. Specifically, phase 2 update will address 2044 population and employment growth targets and associated policies consistent with the Washington State Growth Management Act, the Puget Sound Regional Council's (PSRC) Vision 2050 and their Regional Growth Strategy. KRCC is established by an inter-local agreement as a regional body comprised of members from Kitsap County, the cities of Bainbridge Island, Poulsbo, Bremerton, Port Orchard, as well as the Suquamish Tribe, Port Gamble/S'Klallam Tribe, Port of Bremerton, Port of Kingston, Naval Base Kitsap and Kitsap Transit. One function of KRCC is to facilitate the review and proposed updates to the CPPs.

Not applicable. Local Kitsap Comprehensive Plan policy updates will need to occur consistent with the adopted and ratified CPPs. Local Kitsap jurisdiction updates to their respective comprehensive plans for non-project, programmatic actions will need to conduct their own SEPA review and determination. Kitsap County and the cities within are required to update their comprehensive plans and associated development regulations per the Countywide Planning Policies on or before June 30, 2024.

Kitsap County and the cities within are member jurisdictions of PSRC along with King, Pierce and Snohomish counties and cities. PSRC is a Metropolitan Planning Organization (MPO) and Regional Transportation Planning Organization (RTPO). Per PSRC's inter-local agreement, Kitsap's CPPs must be certified by PSRC to ensure consistency with multi-county planning policies (Vision 2050), as well as local comprehensive plans which must also receive certification including local transportation elements.

The proposed policy amendments to the CPPs are the primary focus of this proposal. Specifically, the proposed revisions are intended to ensure consistency with PSRC's Vision 2050 and any changes to state laws, such as the Washington State Growth Management Act (GMA). The CPPs apply to jurisdictions located within Kitsap County and local comprehensive plans must be consistent with them. The proposed CPPs recommended by KRCC amend the following sections:

- Introduction: Updates to countywide vision statement, objectives, policies for update and ratification.
- Element A Countywide Growth Patterns: Revise's policies related to roles and responsibilities for County and cities, resource lands and working together on the Buildable Lands Program.
- Element B Urban Growth Areas (UGAs): Updates Buildable Lands and Land Capacity policies consistent with changes to the GMA, revises policies when the County receives citizen requested site-specifics for an associated UGA assigned to a city, revises policies related to Urban Growth Area Management Agreements, updates policies for consistency related to UGA expansions, proposes revisions in alignment with PSRC's Regional Growth Strategy, dated March 2018.
- Element C Centers of Growth: Updates chapter in alignment with PSRC's March 2018 Regional Growth Strategy and associated Vision 2050 policies.
- Element D Rural Land Uses and Development Patterns: Proposes new and revised policies on appropriate rural level of services, rural communities, protection of rural lands from sprawl and recognizes certain existing LAMIRDs as Rural Centers but not Centers of Growth.

- Element E Natural Environment: Proposes policy revisions to reflect the Kitsap County Open Space Plan, reduce impacts to vulnerable populations, incorporating anti-displacement policies, collaboration policies to preserve, restore and reduce impacts to the natural environments, as well as policies and actions to address climate change impacts.
- Element F Contiguous, Compatible and Orderly Development: Revisions focus on consistency changes to goals and policies to reflect PSRCs Regional Equity Strategy, displacement including policies ensuring access and services to underserved communities.
- Element G Public Capital and Essential Public Facilities: Proposed revisions clarify differences from GMA and PSRC Vision 2050 between essential public facilities including services of statewide significance and that of public capital facilities. Furthermore, revisions incorporate policies related to siting of public capital facilities, as well as displacement policies when siting or expanding capital facilities.
- Element H Transportation: Updates to this chapter focus on consistency revisions to align with PSRC Vision 2050 including but not limited to displacement policies, establishing level of service standards for multi-modal concurrency, including non-motorized modes and housekeeping edits.
- Element I Housing: Revisions include policies related to missing middle housing and multi-family development, policy revisions that focuses housing in cities and unincorporated urban areas, as well as anti-displacement policies.
- Element J Countywide Economic Development: Incorporates housing keeping edits, references education and training programs, as well as policy to foster and target economic growth in areas with low and very low access to opportunities.
- Element K Fiscal Impact: Housekeeping revisions.
- Element L Coordination with Tribal Governments: Housekeeping revisions.
- Element M Coordination with Federal Government Including Navy: Housekeeping revisions.
- Element N Roles and Responsibilities: Housekeeping revisions, as well as updated references to the Buildable Lands Program, Land Capacity Analysis, policy revisions to encourage coordination and resolve differences on issues impacting Kitsap County.
- Appendix A Ratification Process: Proposes revisions to the ratification process if amendments are related to CPP appendices.
- New Appendix C Centers of Growth: Consistency revisions related to Element C noting centers typology, including a list of centers and their associated categorization as well as candidate countywide centers, consistent with PSRCs Regional Growth Strategy adopted March 2018. This proposed action would include housekeeping deletion/replace of Appendix F: Regional and Kitsap Designated Center List, as well as Appendix G: Centers and LAMIRDS.
- Old Appendix C Urban Growth Management Agreements: Proposed deletion for internal consistency with Element A of the CPPs.
- Appendix D: Proposed deletion as most jurisdictions (except Poulsbo) are not party to the ILA on revenue sharing upon annexation.


