I have been a guardian ad litem since 1997 when I was admitted to the bar in Washington and Idaho. I have been on the Guardian ad Litem registry for Spokane, Pend Orielle, Whitman, Stevens and Grant County. I was on the GAL registry for both Title 26 and for 11.88 for approximately 15 years when I withdrew my name from the Title 26 registry. I have conducted approximately 350 investigations as a Guardian ad Litem for RCW 11.88.

I moved to Bainbridge Island in October of 2022. I am interested in continuing my work as a Court visitor for Kitsap and surrounding counties.
I did not renew my mandatory GAL training in Spokane in October of 2022 but I intend to take the training in King County this spring.

I have been a Guardian ad Litem on the GAL registry for Spokane Pend Orielle, Lincoln, Stevens and Grant County from 1997 to 2020 I also practiced family law in Spokane from 1998- 2015 at which time I closed my family law practice but continued to work as a GAL. Initially I was a GAL in both titles 26 and 11.88 but I did transition to solely 11.88 appointments in 2017. I am very familiar with the legal procedure involved in guardianships and with the requirements of RCW 11.130
I have worked with Alleged Incapacitated Persons in various stages of needing a guardian. In two instances I concluded that a guardian was not necessary. I have worked with mentally disabled young people and I have worked with elderly people for whom a guardianship was petitioned by family members, a care facility or a hospital.
In addition to the required annual GAL training that I took every year in Spokane from 1998 to 2019 I did take some other CLEs that were specific to areas relevant to the needs of persons subject to guardianship. They included Ageing Clients: Estate and Longevity Planning (12/10/16), Mediating and Settling Nursing Home Cases (12/13/16) and Elder Abuse; Advocating for the Golden Years (10/15/18).
