Failure to accurately disclose fees will be cause for disqualification. The only fees that need not be listed are taxes and pass- through fees imposed by regulatory agencies.

<u>Pre-paid Account Set-Up & Funding Fee</u>. If the Bidder charges a fee to set-up a pre-paid account or a fee to fund a pre-paid account, they must state the firm, fixed fee below. If the Bidder does not charge a set-up fee or funding fee for a pre-paid account, they must indicate "N/A" or "\$0.00" in the space provided. The Bidder may either indicate a per funding event fee or a one-time set-up fee for a pre-paid account, but not both. Additionally, the Bidder is strictly forbidden from charging or levying any other fees or charges on pre-paid accounts. The County reserves the right to subjectively evaluate the Bidder's pre-paid account set-up fee and funding fee as part of the evaluation criteria.
