**COOPERATIVE PURCHASING AGREEMENT**

In accordance with chapter 39.34 RCW, Jefferson County agree to a cooperative governmental purchasing agreement for various equipment, services and supplies Kitsap County's competitively awarded contracts.

Kitsap County therefore extends the use of its contracts to Jefferson County to the extent provided by law and upon the following terms:

- (1) The vendor (s) agree to extend to Jefferson County the terms and conditions of Kitsap County's contract (s).
- (2) Jefferson County accepts responsibility for compliance with any additional or varying laws and regulations governing its purchases. Any purchases by Jefferson County shall be effected by a purchase order from Public Works Dept. and directed to the vendor.
- (3) Kitsap County accepts no responsibility for the performance of any of the purchasing contract (s) by the vendors (s).
- (4) Kitsap County accepts no responsibility for payment of the purchase price by Jefferson County.

This agreement may be revoked at any any time in writing by either party.

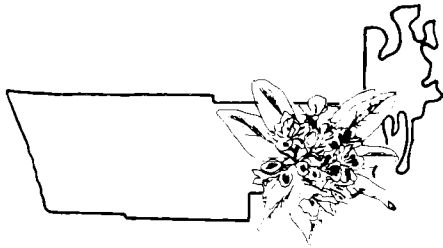
