PROGRAMMATIC DETERMINATION OF NONSIGNIFICANCE

Description of Proposal: **Ordinance related to Stormwater Business Pollution Prevention also referred to as the "Source Control Best Management Practice (BMP) Ordinance"**. This State Environmental Policy Act (SEPA) decision is for the processing of an Ordinance that affects Kitsap businesses and requires them to take measures to stop water pollution before it enters the stormwater system. This requirement is mandated by [Department of Ecology's Western Washington Phase II Municipal Stormwater Permit](#). The ordinance is consistent with the Department of Ecology's mandate that requires businesses to address pollutants such as fertilizers, oil and grease, wash water, etc., that originate from daily business/site activities, spill incidents, improper disposal, or other indirect sources by implementing Best Management Practices (often called BMPs).

This is a non-project action which aims to adopt and make effective an ordinance requiring the application of source control best management practices (BMPs) for pollution generating sources associated with existing land uses and activities to comply with 2019-2024 Western Washington Phase II Municipal Stormwater Permit requirements (S5.C.8).

The following are minimum requirements for a source control code/ordinance (Western Washington Phase II Permit, S5.C.8.b.i): *“No later than August 1, 2022, Permittees shall adopt and make effective an ordinance(s), or other enforceable documents, requiring the application of source control BMPs for pollutant generating sources associated with existing land uses and activities (see Appendix 8 to identify pollutant generating sources).”*

Proposed Ordinance - Source Control for Existing Development would modify the regulations within Kitsap County Code Title 12 – Stormwater Drainage, Chapter 12.20 Stormwater Management by requiring the application of source control BMPs for pollutant generating sources associated with existing land uses and activities. Pollutant generating sources are identified in Appendix 8 fo the 2019-2024 Western Washington Phase II Municipal Stormwater Permit. The requirements of this ordinance are met by using the source control BMPs in the Stormwater Management Manual for Western Washington (SWMMWW).

Unincorporated Kitsap County occupies a unique position in the central Puget Sound region of the State of Washington, located directly between the urban areas of Seattle and Tacoma and the largely undeveloped Olympic Peninsula. It is bounded by the Hood Canal on the west, Puget Sound on the east, and Mason and Pierce Counties to the south. The county is geographically diverse covering a total landmass of 396 square miles, ranking 36th in size among all counties in Washington State.
