CONTRACT AMENDMENT D

This CONTRACT AMENDMENT is made and entered into between SALISH BEHAVIORAL HEALTH ADMINISTRATIVE SERVICES ORGANIZATION, through Kitsap County, as its administrative entity, a political subdivision of the State of Washington, with its principal offices at 614 Division Street, Port Orchard, Washington 98366, hereinafter "SBH-ASO", and Kitsap Community Resources hereinafter "CONTRACTOR."

In consideration of the mutual benefits and covenants contained herein, the parties agree that their Contract, numbered as Kitsap County Contract No. KC-133-20 executed on April 13, 2020, shall be amended as follows:

Page 1 shall be amended as follows:

- Contract Amount is increased by \$731,346, increasing the contract total from \$1,388,571 to \$2,119,917.
- Contract Period: Contract end date is extended to June 30, 2023. The contract period is January 1, 2020 through June 30, 2023.

SUD Subsidy

1/1/20-6/30/20 funding remains unchanged at \$32,000.

7/1/22-6/30-23 funding is added in the amount of \$65,000.

Commerce Long-Term Subsidy

1/1/20-6/30/20 funding remains unchanged at \$33,975.

7/1/20-6/30/21 funding remains unchanged at \$64,000.

7/1/21-6/30/22 funding remains unchanged at \$348,596.

7/1/22-6/30-23 funding is added in the amount of \$316,346.

Governors Housing//Homelessness Initiative 7/1/22-6/30/23 funding is added in the amount of \$25,000.

- Governors Housing/Homelessness Initiative funding is added to provide rental subsidy/bridge funds to individuals discharging from state operated behavioral health facilities.
- 2. If this Contract Amendment extends the expiration date of the Contract, then the Contractor shall provide an updated certificate of insurance evidencing that any required insurance coverages are in effect through the new contract expiration date. The Contractor shall submit the certificate of insurance to:

Program Lead, Salish Behavioral Health Organization Kitsap County Department of Human Services 614 Division Street, MS-23 Port Orchard, WA 98366.

Upon receipt, the Human Services Department will ensure submission of all insurance documentation to the Risk Management Division, Kitsap County Department of Administrative Services.

3. Except as expressly provided in this Contract Amendment, all other terms and conditions of the original Contract, and any subsequent amendments, addenda or modifications thereto, remain in full force and effect.

This amendment shall be effective July 1, 2022.
