## CONTRACT AMENDMENT E

This CONTRACT AMENDMENT is made and entered into between SALISH BEHAVIORAL HEALTH ADMINISTRATIVE SERVICES ORGANIZATION, through Kitsap County, as its administrative entity, a political subdivision of the State of Washington, with its principal offices at 614 Division Street, Port Orchard, Washington 98366, hereinafter "SBH-ASO", and Olympic Community Action Programs hereinafter "CONTRACTOR."

In consideration of the mutual benefits and covenants contained herein, the parties agree that their Contract, numbered as Kitsap County Contract No. KC-134-20, and executed on March 20, 2020, shall be amended as follows:

Page 1 shall be amended as follows:

- Contract Amount is increased by \$2,500 from \$404,901 to \$407,401.
- SABG Support Funds to be used as outline below:
  - Basic Needs
    - Food gift cards in small amounts for use before/after treatment appointments or prevention activities
    - Childcare for treatment, attending support meetings
    - o Identification if needed for treatment or job
    - Minutes on phones if being used for telehealth appointments related to treatment/prevention activities
  - Personal Hygiene and Wound Care Supplies Healthy universal precautions reducing the spread of pathogens
    - Method: First aid kits, hand sanitizer, clean drinking or hygiene bottled water, gift cards for use to purchase specific supplies needed.
  - Transportation
    - Bus Passes, Ferry Passes, Light Rail Passes, ORCA Cards in order to attend treatment/prevention activities
    - Gas voucher small amounts only in order to attend treatment/prevention activities
  - **Contract end date** remains June 30, 2023. Contract period for SABG support funding is November 1,2022 to June 30, 2023.
