CONTRACT AMENDMENT

This CONTRACT AMENDMENT is made and entered into between SALISH BEHAVIORAL HEALTH ADMINISTRATIVE SERVICES ORGANIZATION, through Kitsap County, as its administrative entity, a political subdivision of the State of Washington, with its principal offices at 614 Division Street, Port Orchard, Washington 98366, hereinafter "SBH-ASO", and **Kitsap Mental Health Services** hereinafter "CONTRACTOR."

In consideration of the mutual benefits and covenants contained herein, the parties agree that their Contract, numbered as Kitsap County Contract No. KC-136-20 and executed on May 11, 2020, shall be amended as follows:

Page 1 shall be amended as follows:

- Contract end date is extended to June 30, 2024.
 - Contract period for SUD Peer is March 15, 2023 to March 14, 2024.
 - Contract period for SABG support funding is July 1, 2023 to March 14, 2024.
 - Contract period for HARPS Support Services is July 1, 2023 to June 30, 2024.
- Contract amount is increased by \$351,880 from \$679,980 to \$1,031,860.
 - Increase \$90,000 to fund new Substance Use Peer position.
 - Add \$2500 in Recovery Supports
 - Add \$259,380 for continuation of HARPS Support Services
- Attachment C: Budget is deleted and replaced as attached.
- Attachment C-4 : Deliverables table for 3/15/23-6/30/24 is attached.
- 5. If this Contract Amendment extends the expiration date of the Contract, then the Contractor shall provide an updated certificate of insurance evidencing that any required insurance coverages are in effect through the new contract expiration date.
