AGREEMENT KC-149-24

This Agreement is entered into between Kitsap County Department of Human Services and the City of Poulsbo, Washington.

I. Purpose

This Agreement is for the appropriation of \$168,000 dollars for the purpose of augmenting state and federal funding to provide for a Program Manager for the North Kitsap Resource Center, a Peer Support Specialist and administrative fees.

II. Identification

The City of Poulsbo will use the funding to pay for the salary of a Program Manager, the Peer Support Specialist, and the 5% indirect costs not to exceed \$168,000 funded by this contract for the North Kitsap Recovery Resource Center.

III. Project Description

This project will provide a Program Manager for the North Kitsap Recovery Resource Center for behavioral health, professional services such as peer support, SUDP, nurse and mental health professional, and a 5% indirect cost allowance.

IV. Data Collection and Reporting

The City of Poulsbo will provide a Quarterly Report to the Kitsap County Department of Human Services by April 30, July 31, and October 31, 2024; and January 31, 2025, the number of people referred to the center, the number of people utilizing the center, the number of members, and the number of services accessed at the center.

In addition, outcomes including the participant satisfaction survery that will be provide to all members of the centrer and compliance with diversion agreements for people with court issued diversion agreements who use the center will be included.

V. <u>Billing and Payment</u>

The City of Poulsbo will send a invoice to the Kitsap County Department of Human Services for reimbursement for expenses incurred monthly. Invoices are due by the 15th of each month. The county has 30 days to process the invoice from receipt of invoice submission.

The Department of Human Services will prepare an interdepartmental transfer and make payment to the City of Poulsbo.

Reimbursement shall not exceed the total amount indicated on the Agreement Budget Sheet (Attachment A) \$168,000 of this agreement and any other modifications hereof.

VI. Duration

This agreement is in effect from January 1, 2024 – December 31, 2024.

VII. Amendments

This agreement may only be modified by one or more written amendments duly approved an executed by both parties.



Evidence of Coverage

The City of Poulsbo is a member of the Washington Cities Insurance Authority (WCIA), which is a self-insured pool of over 160 public entities in the State of Washington.

WCIA has at least \$4 million per occurrence limit of liability coverage in its self-insured layer that may be applicable in the event an incident occurs that is deemed to be attributed to the negligence of the member. Liability coverage includes general liability, automobile liability, stopgap coverage, errors or omissions liability, employee benefits liability and employment practices liability coverage.

WCIA provides contractual liability coverage to the City of Poulsbo. The contractual liability coverage provides that WCIA shall pay on behalf of the City of Poulsbo all sums which the member shall be obligated to pay by reason of liability assumed under contract by the member.

WCIA was created by an interlocal agreement among public entities and liability is self-funded by the membership. As there is no insurance policy involved and WCIA is not an insurance company, your organization cannot be named as an additional insured.
