Dear Kitsap County Voters:

You don't need the Kitsap County Auditor to tell you how important this election is. We expect to process more ballots than we ever have in a single election. More relevant to most voters is information about how to make sure you vote on time and that your vote is counted. Many of your questions during this election can be answered at VoteWA.gov.

1. **Am I registered correctly?** Log into VoteWA.gov using your name and date of birth and you will see your registration information. Or, contact us for help. The sooner you check, the more secure you can feel you are ready for the election.
2. **Was my ballot sent to me?** Beginning Oct. 16 you can verify at VoteWA.gov that your ballot was mailed to you. When you check "Ballot Status" it will say "Sent." If you haven't received your ballot by October 26, contact us so we can send you a new ballot. We're at auditor@co.kitsap.wa.us, or (360) 337-7128.
3. **Did the county receive my voted ballot?** If you use one of our ballot drop boxes you can go back to VoteWA.gov within a few days and your ballot status should say "Received." If you mail it, allow a week.
4. **Will my vote be counted?** When you log into VoteWA.gov, if your ballot status says, "Accepted," you're good to go. If it says "Rejected," it may be that your signature doesn't match, that you forgot to sign the declaration, or maybe accidentally signed a ballot declaration for someone else in the family. Contact us so we can help you resolve the issue.
5. **When should I vote?** That's ultimately for you to decide and we're ready to help you whenever you choose, as long as you vote by 8 p.m. on Election Day. However, if there are issues with your ballot, you will have more time to resolve them if you vote earlier. You will also be more likely to have your vote be part of the first night's results.
6. **Where should I vote?** Again, your call. Mark your ballot at home and you'll have 23 ballot drop boxes available until 8 p.m. on Election Day. If you mail your ballot, we recommend you mail it a week ahead of Election Day. Once again we will have three vote centers ready to assist you on Election Day and the Saturday and Monday before Election Day. The center in Poulsbo has a drive-up drop box outside and the vote centers in Port Orchard and Bremerton will have staffed drive-up drop boxes.

As always, please let us know how we can help. Thank you for taking your part in our democracy.

Voter Information

State and Federal Candidates/Measures

The Secretary of State's Office publishes a voters' pamphlet with federal, state and judicial candidates, and statewide measures. That pamphlet will be delivered by the post office to all Kitsap County households and is online at: VoteWA.gov.

General Election Ballot

Statewide measures appear first on the ballot, followed by countywide measures, then federal, state, county, county judicial, and public utility district candidates. Local measures appear after offices for each district.

If a Primary Election was held, the two candidates that received the most votes and received at least 1 percent of the votes cast for that office appear on the General Election ballot. The candidate who received the most votes in the Primary is listed first. Candidates who did not appear in the Primary are listed in the order determined by lottery draw.

Electoral College

The vote for President and Vice President on the General Election ballot is actually a vote for electors who will represent the state in the Electoral College.

Each state gets a number of electors equal to the number of representatives they have in Congress. Washington has 12 electoral votes out of 538 nationwide. Washington is one of 48 states that uses a "winner-take-all" system to allocate electors.

The party of the presidential candidate who receives the most votes in Washington will select the 12 electors to the Electoral College, and they will cast their votes in Olympia on December 14th. Other states' electors will meet and vote on the same day.

Our current electoral college process was last amended in 1804. In 1824, 1876, 1888, 2000 and 2016 the presidential candidate who received the most votes nationwide did not become president.

Questions or Need a Replacement Ballot?

If you have not received your ballot by **October 26**, or if your ballot is damaged or lost, you may request a replacement ballot by contacting Kitsap County Elections.

Participating Jurisdictions

Districts participating in this Local Voters' Pamphlet are: Kitsap County, Kitsap Public Utility District No. 1, Central Kitsap Fire and Rescue, and Kitsap County Fire Protection District No. 7 (South Kitsap Fire and Rescue).

Military, Overseas and Early Ballots

If you are a military or overseas voter or if you believe your ballot will not be received in time to vote, you may request to receive your ballot by email or request an early ballot up to 90 days before an election. Early ballots list only the contests known at the time of the request. To request an email ballot or early ballot, visit: kco.wa.us/elections or contact Kitsap County Elections at auditor@co.kitsap.wa.us.

Write-Ins – Which Votes Can Be Counted

General Election write-in votes can only be counted if:

- The candidate filed a Declaration of Write-in Candidacy, and;
- In a General Election there are enough write-in votes for a candidate to win.

Candidate and Committee Statements

The Local Voters' Pamphlet includes statements submitted by candidates running for offices and committees supporting or opposing ballot measures. Statements printed in this pamphlet are the opinions of the authors. Kitsap County Elections is not responsible for the content of statements or their factual and grammatical accuracy.

Your Right to Privacy

Every voter has the right to vote his or her ballot in secret. A person voting when he or she is not qualified, or falsely signing the Ballot Declaration, is a felony punishable by up to five years of imprisonment or a maximum fine of \$10,000, or both imprisonment and fine.

Register to Vote

Who May Vote

To be eligible to vote, one must register and be:

- A citizen of the United States.
- A legal resident of the state of Washington.
- At least 18 years of age by the next election.
- Not under the authority of the Department of Corrections for a Washington felony conviction.

How to Register

- Online at www.VoteWA.gov.
- Complete a mail-in registration form available at VoteWA.gov or at the County Auditor's Office.
- When you renew your driver's license.

Update Your Voter Record if You Move

If you are already registered to vote in Kitsap County, update your voter record online at: www.VoteWA.gov through October 26. You may also email the Kitsap County Auditor – Elections Division at auditor@co.kitsap.wa.us or call 360-337-7128. Address changes can be made in person until 8 p.m. on Election Day at the Kitsap County Auditor's Office and at the Vote Centers. Dates and locations under the "When to Register" section. A new voter registration card will be mailed after your address change is processed.

When to Register

Individuals may register to vote at any time. To vote in the November 3 General Election, the deadlines are:

- **October 26:** Deadline for **mail and online** voter registrations, updates and changes.
- **November 3:** **In-person** deadline for voter registrations, updates and changes. Citizens may register until 8 p.m. on Election Day by appearing in person at the County Auditor's Office. Registration will also be available the Saturday and Monday before Election Day and on Election Day at the Vote Centers at the Marvin Williams Recreation Center, the Kitsap County Administration Building and the Poulsbo Fire Station.

Name Change

If you have legally changed your name, you must complete a new voter registration application. Your new signature is used to validate your ballot.

To Cancel Your Voter Registration

You may sign a form requesting to cancel your registration. In the case of a deceased voter, a family member may sign a form authorizing a cancellation. The form is available by contacting the Kitsap County Auditor's Office or at <https://www.kitsapgov.com/auditor/Documents/CancellationForm.pdf>.

Political Party Information

Major Political Parties

A political party qualifies as a “major” political party when it receives at least 5 percent of the total votes cast in any statewide office contest at the preceding state General Election in an even-numbered year. In 2020 Washington state has two major political parties: Democratic and Republican.

Minor Political Parties

A “minor” political party is any political party in which no candidate for statewide office received at least 5 percent of the total votes cast at the preceding General Election during an even-numbered year.

Candidates for Partisan Office

A candidate may state on the ballot a political party that he or she prefers. A candidate may choose to not state a party preference.

A candidate’s party preference does not imply that the candidate is nominated or endorsed by the party or that the party approves of or associates with that candidate.

The election for President and Vice President is different. Candidates for President and Vice President are the official nominees of their political party.

Contributions to Candidates and Political Committees

- **Contribution Limits** – State law sets contribution limits on donations to legislative, judicial and county candidates as well as bona fide political party and caucus political committees.
- Anyone who donates more than \$25 in monetary and in-kind contributions must be identified by name and full address. For donations of more than \$100 – occupation, employer name, city and state of his/her employer are also required.

Candidates for State, Federal and Judicial Offices

In the General Election, statements from these candidates are published in the State Voters’ Pamphlet.

Candidates for County Offices

Statements for candidates for county races are subject to RCW 29A.32 sections 210-280 and Kitsap County Administrative Rules. Once deemed compliant they are printed exactly as submitted. Kitsap County Elections does not correct punctuation, grammar, typos or inaccurate information.

Accessible Voting, Vote Centers, and Online Access

Federal law requires jurisdictions to provide vote centers with certified accessible voting devices, which enable voters with disabilities to cast their ballots independently and in private.

Accessible Voting Units provide all contests in audio and high-contrast text formats and are available beginning 18 days prior to the General Election.

Online Access

Kitsap County Elections provides an accessible online Local Voters' Pamphlet. The online pamphlet also allows voters to access their specific ballot using the internet.

Please note: Online access to your ballot is not online voting. It simply allows you to access and print a ballot from your computer. You would then return it using one of our drop boxes, at a vote center, or by mail.

It is compatible with commonly used accessibility software such as screen readers and screen magnifiers, and allows for navigation without the use of a mouse and without having to see the cursor on the screen. All candidate video statements are close captioned.

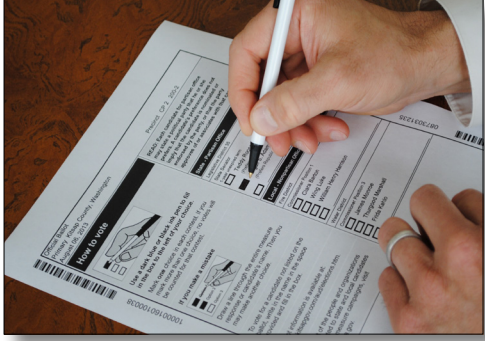

Mark and Return Your Ballot

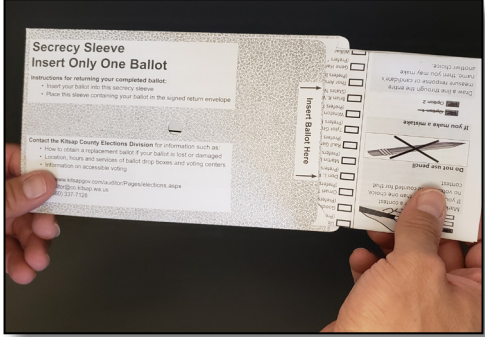
How to vote

Use a dark blue or black ink pen to completely fill in the box to the left of your choice. **Do not use pencil.** Mark one choice in each contest. If you mark more than one choice, no votes will be counted for that contest.



Secure

Place the voted ballot in the secrecy sleeve.
Place the secrecy sleeve inside the lavender return envelope.



Sign, Date and Seal

Read, sign and date the Ballot Declaration on the lavender return envelope.

- The lavender return envelope must be signed by you in order for your ballot to be counted.
- Sign your name in dark ink.
- Seal the lavender return envelope.



Ballot Drop Boxes

Use one of the 23 Kitsap County 24-hour ballot drop boxes listed on page 4.
Ballot drop boxes close at 8 p.m. on Election Day.



Mail

Mail your ballot early enough to be postmarked on time. We recommend you mail your ballot by Oct. 27, one week before voting ends.

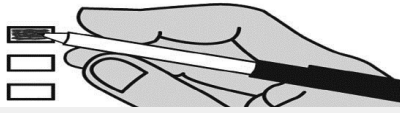

How to vote this ballot

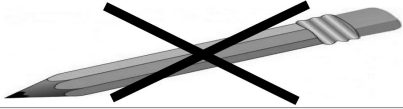

The legislature imposed, without a vote of the people, a retail sales tax on pass-through charges retail establishments collect for specified carryout bags, costing \$32,000,000 in its first ten years, for government spending. This tax increase should be:

Substitute Senate Bill 5628

Advisory Vote No. 34

Engrossed Substitute Senate Bill 6492

Advisory Vote No. 35

Engrossed Senate Bill 6690

Engrossed Senate Joint Resolution No. 8212

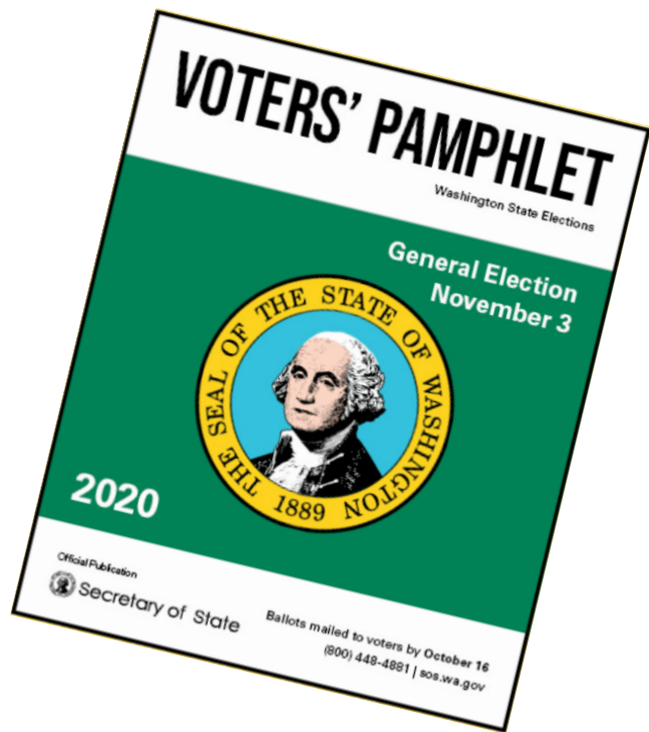

Official Ballot Title

The Board of Commissioners of Central Kitsap Fire and Rescue adopted Resolution 20-05, concerning emergency services facilities to protect public health, life, and property. This proposition would allow the District to strategically combine and replace five fire stations, remodel four fire stations, and perform related capital improvements to better protect the community, improve response times, seismically upgrade fire stations, acquire equipment, improve operational efficiencies, and provide firefighters a healthier, safer work environment; issue no more than \$58,300,000 of general obligation bonds maturing within 20 years; and levy annual excess property taxes to pay these bonds, pursuant to Resolution 20-05.

Explanatory Statement (Prepared by the Attorney for the district as prescribed by law.)

Proposition 1 authorizes the issuance of general obligation bonds of no more than \$58,300,000 for the purpose of constructing, replacing, remodeling, and performing seismic upgrades to fire stations, including related equipment and improvements. The bonds will be payable from an annual excess property tax levy for up to 20 years.

Central Kitsap Fire and Rescue provides fire protection, rescue and emergency medical services to 72,000 residents. Passage of Proposition 1 would allow Central Kitsap Fire and Rescue to address critical facility needs identified in the District's 2019 Capital Facilities Plan. Specifically, Proposition 1 would enable the District to reduce response times, improve firefighter health and safety, and improve operational efficiencies.

Many stations are 60 years old and none are up to current seismic standards. Some are located significant distances away from populated areas, which increases response times. Most are too small to shelter modern apparatus, which leaves these expensive pieces of equipment vulnerable to weather and reduces their life span. Stations lack facilities to accommodate a multigender workforce or living quarters that can allow for 24-hour staffing.

Cancer is a leading cause of firefighter deaths. Some stations lack effective diesel exhaust removal systems and decontamination areas to reduce firefighter exposure to these cancer-causing carcinogens and infectious diseases. Other stations lack effective security systems, sprinklers and fire alarms.

Fire stations are too expensive to fund through daily operating levies. The tax levy to pay the bonds is projected to be 32 cents per \$1,000 of assessed property value.

Argument For the Measure

Improve the health and safety of our community and our firefighters.

Central Kitsap Fire and Rescue (CKFR) has provided fire and life safety services to residents and businesses since 1942. They respond to over 8,600 emergency calls per year and are one of the county's largest emergency service providers. CKFR is a responsible steward of taxpayer dollars, operates under a balanced budget, and has passed all financial and accountability audits with the State of Washington.

Population and commercial growth in our fire district continues to be among the highest in the county. CKFR has personnel and apparatus to respond to calls, but the fire stations are not adequate to support our community or our firefighters.

Facility Health and Safety Concerns

Stations do not meet current seismic standards and could collapse in an earthquake.

Some are located in remote areas, which increases response times.

Stations lack effective diesel exhaust removal systems and decontamination areas, exposing our firefighters to cancer-causing carcinogens and infectious diseases.

And most stations are too small to shelter modern apparatus, which leaves expensive pieces of equipment vulnerable to weather and shortens their lifespan.

Explanatory Statement (Prepared by the Attorney for the district as prescribed by law.)

Passage of Proposition No. 1 would allow Kitsap County Fire Protection District No. 7 (South Kitsap Fire and Rescue) to borrow \$39,500,000 by issuing general obligation bonds. In accordance with Resolution No. 2020-06 approving this proposition, the bonds will pay for the costs of combining and replacing five fire stations with three new fire stations, remodeling the headquarters campus and making seismic upgrades to stations throughout the District. The bonds would be repaid out of annual property tax levies over a period of up to 20 years.

South Kitsap Fire and Rescue provides fire protection, rescue and emergency medical services to 75,000 residents in the South Kitsap area. Passage of Proposition 1 would allow South Kitsap Fire and Rescue to address critical facility needs identified in the District's Capital Facilities Needs Assessment. Specifically, Proposition 1 would enable the District to reduce response times, improve firefighter health and safety, and improve operational efficiencies.

A number of fire stations are 40 to 50 years old and were never designed to house career staffing or have space for today's larger apparatus and equipment needs. Five stations are simply at the end of their lifespan with failing septic systems, wells, and building infrastructure. Several of our existing stations are in need of structural upgrades to make them sound and continue to function in the event of natural disasters or other major emergencies.

Over the District's 75-year existence, our community has grown and populations have developed in specific areas such as Manchester, McCormick Woods, Old Clifton, and Bethel-Burley.
