While it is appreciated that you are interested in trying to gain a full perspective of the proposed amendments, at this time the Department believes the amendment process and the existing record before the Planning Commission are code compliant and adequate for the Planning Commission to provide recommendations on the docket of proposed amendments.

Given that the Commission has only the September 18<sup>th</sup> meeting to complete deliberations on the remaining four amendments and adopt Findings of Fact, the Department recommends deliberations remain focused on only the specific facts relevant to the proposed amendments and the review of the attached materials should be considered optional.

I will be including some time at the September 18 meeting, prior to resuming your deliberations, to discuss if and how you may want to consider the attached information more fully. Perhaps we can reserve a future meeting where we can have a broader discussion of the County's Comprehensive Plan amendment process. I think going through an "after action exercise" would be worthwhile.
